

TRUMAN D. PICARD SCHOLARSHIP FACTS & QUESTIONS FOR APPLYING

FOR NATIVE AMERICAN STUDENTS
IN NATURAL RESOURCE MAJORS



BACKGROUND

- First awarded in 1988 in honor of Truman Picard, Colville forester and member of ITC Board of Directors
- Enrolled tribal members pursuing natural resource degrees
- 558 recipients to date
- \$1,228,000 awarded to date
- \$4,000 for undergraduate and graduate students studying Forestry or Fire
- \$3,000 for undergraduate and graduate students studying Natural Resources
- \$2,000 high school students studying Natural Resources, Forestry or Fire

ELIGIBILITY

- Must be an enrolled member of a federally recognized tribe or Alaska Native Corporation
- College students: Must be a natural resource major (examples: forestry, hydrology, wildlife & fisheries, natural resource management or environmental studies.)
- High school students: Must be enrolled in natural resource courses
- College seniors not eligible unless they are applying to graduate school
- All natural resources degrees accepted, but preference will be given to students whose degree or area of study directly involves management of Forest Resources.
- Award given in early summer and intended to support student for the *following year*

THE PROCESS

- Members of the ITC Education Committee will review applications
- Each reviewer grades applications on a 1–5-point basis for each of 5 categories (25 points total). Scores for all reviewers are added together and candidates ranked.
- Categories are: 1) Application letter 2) resume 3) academic merit 4) financial need 5) three letters of reference

REQUIRED MATERIALS-

I) LETTER OF APPLICATION

- This is required and is worth up to 5 points - it is a great opportunity to introduce yourself to the reviewers
- Letter of application - 2 pages max discussing the following: a) Your name, permanent mailing address, email address, and phone number. b) School currently enrolled in or accepted to, declared major, and expected graduation date. c) Interest in Forestry and/or Wildland Fire Management. d) Commitment to education, community, and your culture. e) Financial need.
- Successful applicants frequently talk not only about themselves, but their tribe and the applicant's relationship to the land, culture and how it relates to their field of study in natural resources
- Career goals and family are often also mentioned- tell the story of why you are in college and why you want assistance from an intertribal forestry group
- Discuss why you need the financial assistance and how you would use it

REQUIRED MATERIALS-

2) RESUME

- Worth up to 5 points
- There is no required “correct” format- just make it easy to read and well organized
- Highlight education and work experience. If you have natural resource work and/or volunteer experience, make sure you detail it
- If you don’t, no worries, list any work and volunteer experience
- Membership in clubs or groups, awards, etc. are all worth mentioning

REQUIRED MATERIALS-

3) THREE LETTERS OF REFERENCE

- Three letters of reference required - worth in total up to 5 points
- Letters must be signed (digital & electronic signature accepted), dated, and on letterhead (or reference the organization that the person represents). General letters of reference are ok, but need to be less than 6 months old
- Think strategically about who you will ask and give them a bit of time. When possible, get a mix of academic and work references. Personal references (friends of the family, a pastor etc.) are also acceptable, but in general solid references from instructors and employers tend to carry the most weight
- Open sealed documents, if applicable
- Reference letters will not be accepted directly from references. They should be included in your final application delivery

REQUIRED MATERIALS-

4) PROOF OF TRIBAL ENROLLMENT

- This is not a graded category, but to have your application accepted by ITC you must prove that you are a member or descendant of a federally recognized tribe or Alaska Native Corporation
- Accepted documents include a photocopy of your member or descendent enrollment card, front and back, or completed BIA Form 4432 Verification of Indian Preference for Employment, download at <https://bit.ly/BIAForm4432>

REQUIRED MATERIALS- 5)TRANSCRIPTS

- This is the major piece of evidence for the Academic merit (1-5 points) category
- Transcripts can be unofficial; you can print copies available to you through you College and include them in the packet
- If you have attended multiple institutions, it is always good to include all transcripts
- Provide proof of declared major and current class schedule

REQUIRED MATERIALS-
6) FREE APPLICATION FOR STUDENT AID
(FAFSA)

- NOTE- ALL applicants must submit a FAFSA report to demonstrate need. You don't have to have "unmet need" in the FAFSA - just include it (reviewers rate financial need on a 1-5 scale)
- If it has not been completed, include last year's report

REQUIRED DOCUMENTS

APPLICATION CHECKLIST

- Letter of Application (2 pages max discussing the following) a) Your name, permanent mailing address, email address, and phone number. b) School currently enrolled in or accepted to, declared major, and expected graduation date. c) Academic interest in Forestry and/or Wildland Fire Management. d) Commitment to education, community, and your culture. e) Financial need.
- Resume
- Reference letter #1 (on letterhead, signed and dated)
- Reference letter #2 (on letterhead, signed and dated)
- Reference letter #3 (on letterhead, signed and dated)
- A copy of your member or descendant enrollment card for a federally recognized tribe or Alaska Native Corp, or completed BIA Form 4432 Verification of Indian Preference for Employment
- Transcripts
- College acceptance letter (high school) or declared major & current class scheduled (college)
- FASFA student aid report

DELIVERY OF APPLICATION

Applications are accepted by Email or Mail, please chose ONE option for Delivery.

Option #1 Email:

Create one email and attach all required documents from the application checklist and submit to (intertribaltimbercouncil@gmail.com) up until the close of business (5:00 p.m. PT) **March 21, 2025**. PDF attachment(s) preferred, download free Adobe Acrobat Reader <https://get.adobe.com/reader/> to view and print PDF documents. Google docs are not accepted.

Option #2 Mail:

Mail all required documents from the application checklist to arrive at the ITC office on or before **March 21, 2025**. Be sure to check local post office hours and transit time if mailing your application. ITC will not be onsite to sign for package deliveries. FedEx and UPS require a physical address for delivery, please contact ITC before using one of these services.
