One person uses a ricing pole to maneuver the canoe throughout the rice beds. The other person uses two cedar sticks to “knock” the rice from the plant into the canoe with sticks called knockers. **Snowshoe Hare Habitat Restoration Tribal Forest Protection Act (TFPA) Pilot Project**

This stop was a TFPA proposal submitted to the Chippewa National Forest to restore areas adjacent to northern white cedar lowlands for secondary habitat to assist populations of snowshoe hare, a keystone species on the Leech Lake Reservation.

**Multiple TFPA site for Red Pine Plantation Ecosystem Restoration and Fire Ecology Restoration**

This stop will show the initial TFPA project to return red pine plantations to a more ecologically functioning system. It is also a site of TFPA for Fire Restoration which is being set the site up for a return of fire. This stop has also become our 2018 Farm Bill 638 Pilot Authority with USDA Project that is drafted as a combination of plantation thinning/ diversification work while utilizing Reserved Treaty Rights Lands (RTRL) grant funds to work towards eliminating fuel loading to plan for fire restoration.
